



Player Fee Breakdown

Dear Parents/Players, Welcome to Renegades FC. As we prepare for the upcoming competitive season, we would like to take the opportunity to address the fees that are involved when providing our players with quality and detailed training that develop their necessary skills in becoming successful and competitive soccer players. Below is a detailed explanation of those fees: Read the full packet.

1. I Understand this is a 12-month commitment of 2400\$ PER PLAYER. (Multiple payment plans online)
2. Registration fees cover; League Registration, Player ID (US Soccer), Coaches payments Practice & Game Fields, Lining of league game fields, Team Insurances, Operating and administrative costs.

*The player registration fee does not cover, Uniforms, Scrimmage Ref fees, scrimmage game fields, practice fields outside of league time play. Coaches Equipment These fees will be covered by the team when needed.

Payment Rule: Total registration fee is due upon registration / before a player receives official player card. If financial arrangements need to be made, it is the responsibility of the parent/guardian to communicate those needs with their assigned Head Coach + Team

3. The Uniform fee is a one-time payment fee of \$199 for new players. All existing players do not need to purchase a new uniform unless required by Team Management.

All damaged or lost items must be replaced and purchased by the player. It is the player's responsibility to take care of the competitive uniform. Club kit includes; Home & away jerseys, home and away socks, home and away shorts, Practice tee.



By signing this contract/agreement with Renegades FC, you are agreeing to comply to all the rules and payments associated. By registering your player, you are allowing RFC to have full ownership of the player card for the full length & time frame of the competitive league. Withdrawing from the club before or mid-season will result in a \$150 penalty fee. *Important, Renegades FC is a Non-Profit / 501 C3 program, no refunds will be made upon registration. You can receive a receipt for your donation for tax deductions purposes only.

The Institution neither assumes responsibility nor provides insurance coverage for any such personal injuries or property damage.



3.0 Assumption of Risks Involved

Knowing the dangers, hazards, and risks of such activities, and in consideration of being permitted to participate in the activity, the Undersigned, on behalf of the minor participant, does release, and forever discharge, waive, and covenant not to sue the Institution, its governing board, officers, agents, employees, the State of California, and any person acting as employees in their official and individual capacities ("Releasesm), from and against any and all liability for any harm, injury, damage, claims, demands, actions, causes of action, costs, and expenses of any nature whatsoever which Participant may have or which may hereafter accrue to the Undersigned, arising out of or related to any loss, damage, or injury, including but not limited to suffering and death, that may be sustained by Participant or by any property belonging to Participant, whether caused by the negligence or carelessness of the releases, or otherwise, while in transit to or from locations where program activities are being conducted.

Player Code of Conduct

Achieving a high level of sportsmanship from our players starts with each player. Playing soccer for and membership in the Renegades FC and within our affiliates at the State and

National level is a privilege and not a right. As with all privileges there comes the responsibility to maintain that privilege. One of your player responsibilities is to conduct yourself in a way that reflects positively on yourself, your Coach, your teammates, your family, the RFC and the game of soccer. Players who do not conduct themselves appropriately will be subject to discipline with the RFC or its governing authorities and that could include removal from the Club. Listed below are behaviors you are expected to exhibit at all times.

1. I will observe the laws of the game at all times and the highest level of sportsmanship.
2. I will be present for all practices and games physically possible
3. I will control my language and not use foul or inappropriate language while participating in soccer related activities.
 3. I will never taunt, yell, or gloat at opposing players and teams.
4. I will treat my fellow teammates with respect and encouragement, not criticism.
5. I will respect my opponents and shake hands at the completion of a game. This may not always be easy depending on how the opposition conducts itself. RFC players rise above the behavior of those who do not represent the game of soccer favorably.
4. I will treat officials with respect and dignity. I will remember that they are in control of the pitch (field) and acknowledge that they are human and will make mistakes. Open confrontation with the officials in the end will not serve my team well. The officials will have the last word even if results in my being sent off the pitch.



6. I will follow and learn from my coaches' direction.
 7. I will work hard, play fair & work to always improve my soccer skills.
 8. I will adhere to the highest standards and the regulations of RFC and its governing authority.
 9. I will seek to honor those who uphold the highest standards and principles of soccer and will use appropriate protocol to oppose and eliminate all behavior that brings disrepute to the sport, e.g. violence, abuse, dishonesty, disrespect, gossip and violations of the laws of the game and rules governing competition.
 10. I will not and cannot play for any other club team while registered with RFC.

Parent Code of Conduct

Achieving a high level of sportsmanship from our players starts with the parents. Membership in the Renegades FC and attendance at all soccer events is a privilege and not a right. As with all privileges there comes the responsibility to maintain that privilege. One of your responsibilities as a parent or guardian is to conduct yourself in a way that reflects positively on yourself, your child, your child's team, your family, RFC and the game of soccer. Soccer is the player's game. Parents who do not conduct themselves appropriately will be subject to discipline with RFC and/or its governing bodies that could include removal from the RFC. The Club is dependent on the parents to set an example for coaches, players, spectators, and officials. Listed below are behaviors you are expected to exhibit at all times.

1. I will learn and follow the laws of the game at all times.
2. I will have my athlete present for as many practices and games physically possible year round
3. I will have my athlete present for all games during season (Sept-Nov)
4. I will finish the length of the contract to ensure team growth and progress
5. I will remember that the game is for the players and not for the adults.
6. I will recognize that soccer demands that my child makes decisions on the pitch (field) and that my child will make and learn from mistakes. Yelling instructions keeps my child from
7. learning because it may be contrary to what the Coach has told him and it may hinder him from making his own decision.
8. I will control my language and not use foul or inappropriate language while participating in soccer related activities.
9. 5. I will have my child arrive on time for all practices and games. I will notify the Coach well in advance whenever there is a problem in attending a scheduled event.
10. 6. I will let the Coach know my thoughts and not yell directions and instructions from the sidelines.



7. I will talk to the Coach privately and not in front of others if issues arise.
8. I will respect the opposing team and not cause or seek out any confrontation.
9. I will respect the game officials and not make comments from the sidelines about decisions made on the pitch. I will remember that they are in control of the pitch and acknowledge that they are human and will make mistakes. Open confrontation with the officials in the end will not serve my child's team well. The officials will have the last word even if it results in my being ejected from the pitch or the area.
10. I will only shout or speak words of encouragement from the sidelines and I will cheer for all players.
11. I will not encourage any behavior that would endanger the health or well-being of the athlete.
12. I will value skill development, fair competition and effort.
13. I will adhere to the highest standards and the regulations of RFC and its governing authority. I will seek to honor those who uphold the highest standards and principles of soccer and will use appropriate protocol to oppose and eliminate all behavior that brings disrepute to the sport, e.g. violence, abuse, dishonesty, disrespect, gossip and violations of the laws of the game and rules governing competition.
